### **TERMS OF SEASON PASS**

- This contract also applies to Sugarbush Golf Club for those who purchase the dual Season Pass option.
- Outdoor golf season passes are valid for the full 2026 golf season
- Season Pass holders do not receive an equity stake in the facility or any other privileges not identified in this Season Pass contract.
- The Captain's Club Golf & Event Center season pass is non-transferable. A valid season pass is conditioned upon completion and acceptance of this season pass contract and receipt of all applicable fees.
- Season passes shall cease and terminate upon the death of the Season Pass holder; refund of a season pass will not be issued but may be transferred to an immediate family Season Pass holder.
- All outdoor season passes include the following:
  - Unlimited Greens Fees with Cart
  - 50% off outdoor league play
    - Age 18+ for league participation
    - No cost reduction for league opt-out, non-transferrable
  - 10% Restaurant food and beverage discount, indoor only (no discount on beverage cart purchases). 20% pro shop soft goods discount. 10% pro shop hard goods discount.
  - Two-week advanced tee time scheduling
- Outdoor Season Pass holder guest guidelines
  - Up to three guests at guest rate, per day
  - Outdoor Season Pass holder guest rates
    - 18 Holes: \$50/guest WD, \$60/guest WE
    - 9 Holes: \$33/guest WD, \$38 per guest WE
  - Guests cannot play at guest rate without the Season Pass holder present
  - Guests cannot play on holidays or weekends before 12pm

### **SEASON PASS HOLDER CONDUCT**

- Proper golf etiquette is expected on the premises and online. Use of abusive/offensive language and/or physical contact to other Season Pass holders, patrons, guests or The Captain's Club Golf & Event Center staff and lewd or illegal behavior is not tolerated.
- The Season Pass holder and/or Season Pass holder guest will be held responsible for any and all damages incurred on The Captain's Club Golf & Event Center property.
- All Season Pass holders and guest must wear collared shirts.
- Metal spikes, work boots and any other footwear deemed unacceptable golf attire are prohibited.
- Cut-offs, t-shirts, tank tops, tube tops and bathing suits are prohibited.
- Season Pass holders and/or guests are not allowed to use The Captain's Club Golf & Event Center property without proper authorization.

## **GOLF COURSE RULES OF USE**

- **Season Pass holders** must identify themselves prior to scheduling tee times. All Season Pass holders must check in with the The Captain's Club Pro Shop staff before using the facility or services. Season Pass holders are allowed to schedule tee times up to 14 days in advance.
- A receipt for golf, cart, range and any other service is required and must be available upon request.
- NO OUTSIDE FOOD, BEVERAGES OR COOLERS are allowed on The Captain's Club Golf & Event Center premises. NO EXCEPTIONS.
- Season Pass holders are not permitted to take a cart on the property to look for and/or hunt golf balls. All players found not using the property for its intended purpose will be asked begin play or asked to take the cart back to the staging area.
- A season pass is not valid for any outing, event or tournament unless otherwise specified. Management also reserves the right to schedule golf events, special outings and tournaments. During events and tournaments, Season Pass holders may not be able to use The Captain's Club Golf & Event Center's facilities.
- The Captain's Club Golf & Event Center may be closed at any time due to weather or other scheduled events. The opening and closing dates for the golf course is up to the sole discretion of Management.
- Minors under the age of 18 are welcome on the golf course and in the clubhouse when accompanied by an adult.

## **GOLF CART RULES OF USE**

In consideration of the rental of this golf cart, Season Pass holder agrees to leave the cart in the same condition as it was received, reimburse The Captain's Club Golf & Event Center for all damages sustained to the cart or property during this rental period, defend, indemnify and hold The Captain's Club Golf & Event Center LLC & its agents harmless from and against all claims, suits and liabilities, without limiting the generality of the foregoing, for any and all damages to property or person, including, but not limited to injury, death or damage to any property whatsoever, caused by, arising from, incident to, connected with, growing out of, or related to the use and/or operation of this golf cart during this rental and agree to not allow any person without a valid driver's license to operate a golf cart. Single cart usage is only allowed when playing alone or as the third player in a group of three. Consolidation of carts will be required or be subject to a \$10.00 additional cart charge.

## **MEDIA RELEASE**

From time to time, The Captain's Club Golf & Event Center may publish photographs or videos online or in marketing materials. You hereby give The Captain's Club Golf & Event Center, its successors and assigns the right and permission to publish or post, for art, advertising trade or any lawful purpose whatsoever, your name, photograph and/or likeness.

## **CONVERSION/UPGRADE POLICY**

**Season Pass holders** have a 30-day period to convert the season pass contract and upgrade the season pass classification. All previous payments will be applied towards the converted or upgraded season pass.

## **TERMINATION & SUSPENSION**

- All The Captain's Club Golf & Event Center season passes may be revoked, suspended or removed without refund for any of the following reasons: (NOTE: Certain privileges may be revoked without revoking all privileges).
  - Physical or verbal abuse of other Season Pass holders, guests, patrons or The Captain's Club Golf & Event Center staff, in person or online.
  - Drinking in excess on The Captain's Club Golf & Event Center property.
  - Willful destruction of club, staff or customer property or premises.
  - Commission of a felony, misdemeanor theft or other activity on The Captain's Club Golf & Event Center property.
  - Violation of The Captain's Club Golf & Event Center policies and rules.
  - Any conduct that detracts from managements rights to manage The Captain's Club Golf & Event Center and preserve its integrity.
- Any Season Pass holder who violates the policies and rules contained in this contract shall be subject to suspension and/or immediate revocation of their season pass without refund or fees. Season Pass holders found to be in violation of the policies and rules may be denied all club privileges. The denial of privileges may apply to one or more family Season Pass holders at managements sole and absolute discretion.

## **MISCELLANEOUS**

- The policies set forth in this contract replace all prior rules and regulations and all other season pass agreements implemented in the past. Prior agreements are no longer valid and are not binding to the management.
- Management reserves the right to refuse the sale of a season pass to any person or party with or without cause.

## **CHANGE OF ADDRESS**

All Season Pass holders must notify The Captain's Club Golf & Event Center staff of any changes to their name or address.

## **LIMITED LIABILITY**

- In no event shall The Captain's Club Golf & Event Center its officers, employees or agents be liable for loss of any kind whether direct or indirect, special or consequential, even if The Captain's Club Golf & Event Center has been advised of the possibility of such damages arising from any defect or error.
- As a Season Pass holder, I release and agree to hold harmless, indemnify and defendThe Captain's Club Golf & Event Center LLC and its owners, agents, servants, associations, employees or anyone connected to The Captain's Club Golf & Event Center from and against any and all injuries, damages, claims and cause of action under any theory of law or equity including their own negligence, which I have or may in the future have as a result of injuries or damages sustained or incurred while on the premises of The Captain's Club Golf & Event Center.

## **CREDIT CARDS**

Season Pass holders must submit a credit card to be held on file for the duration of the season pass. Cancellation of a tee time less than 24 hours in advance or a no-show to a tee time will result in a charge to the credit card on file in the full, season pass, rate of the reserved tee time(s). It is the responsibility of the Season Pass holder to update the credit card on file in the case that the card expires or changes at anytime during the season pass year. Declined cards will result in a \$50 fine. Season passes purchased by credit card are subject to a 3% transaction fee.
